## About this document

This Target Market Determination (TMD) is required under section 994B of the Corporations Act 2001 (Cth) (the Act). This TMD describes the class of consumers that comprises the target market for the financial product and matters relevant to the product's distribution and review (specifically, distribution conditions, review triggers and periods and reporting requirements). Distributors must take reasonable steps that will, or are reasonably likely to, result in distribution of the product being consistent with the most recent TMD (unless the distribution is excluded conduct).

This document is not a Product Disclosure Statement (PDS) and is not a complete summary of the product features or terms of the product. ## Target Market Summary

The Perpetual Geared Australian Share Fund is designed for consumers who are seeking **Capital Growth**, are intending to use the Fund as a **Satellite allocation** within a portfolio, have a minimum investment timeframe of **7 Years or longer**, have a **Very High** or **Extremely High** risk and return profile, are unlikely to need to access their capital within **One Week** of request.

## Investment products and diversification

A consumer (or class of consumer) may intend to hold a product as part of a diversified portfolio (for example, with an intended product use of minor allocation). In such circumstances, the product should be assessed against the consumer's attributes for the relevant portion of the portfolio, rather than the consumer's portfolio as a whole. For example, a consumer may seek to construct a balanced or moderate diversified portfolio with a minor allocation to growth assets. In this case, a product with a High risk/return profile may be consistent with the consumer's objectives for that minor allocation notwithstanding that the risk/return profile of the consumer as a whole is Medium. ## About the Fund

**Investment Objective:** Aims to enhance long-term capital growth through borrowing (gearing) to invest predominantly in quality Australian industrial and resource shares and outperform the S&P/ASX 300 Accumulation Index (before fees and taxes) over rolling three-year periods.

**Product Description:** The Fund has the following key attributes:

- Designed for higher capital growth (and losses) through the investment in predominantly quality Australian shares in a Fund through borrowing (gearing).
- Designed to pay income on a half-yearly basis given the Fund's investment universe. However, there is no guarantee that the Fund will be able to pay income in the future in any particular distribution period and the level of any income may vary materially from one distribution period to next.

**Portfolio Diversification:** The Fund is comprised of 90- 100% Australian shares (includes up to 20% allocation in international shares) and 0- 10% cash. The Fund's gearing level is 0-60% of the total gross asset value.

As the Fund provides exposure to predominantly Australian shares, its portfolio diversification has been assessed as 'Low' and most appropriate as a satellite allocation as a % of investable assets.

**Risk Level:** Specific risks associated with this fund include:

**Investment Volatility Risk:** The risk there is a higher level of volatility in the value of your investment because of a particular asset class or investment strategy. The value of your investment may vary significantly from day to day.

**Drawdown Risk:** The risk of a steep decline in value of an investment portfolio from a relative peak. Any time taken to recover a drawdown can vary considerably due to the nature of the underlying assets, the investment strategy, market conditions and the size of the drawdown.

**Gearing Risk:** \* With gearing, the investment manager borrows money from a lender to increase the amount the fund can invest. While this can result in larger investment gains in a rising market, it is also likely to magnify losses in a falling market. \* Gearing increases the volatility of a fund's investment returns. Consequently, a geared fund is considered to have a higher investment risk than a comparable fund that is ungeared.

**Asset Class Concentration Risk:** Investing in a fund with exposure to predominantly one asset class such as Australian shares may lead to more volatile returns than investing in a fund with a more diversified portfolio with exposure to multiple asset classes.

The Fund's standard risk measure (SRM) is 6 (High), which is reflected in the PDS. The SRM is based on industry guidance and is not a complete assessment of all forms of investment risk and as a result, based on the above specific risks, we consider the Fund is most suitable for consumers who have a very high or extremely high risk and return profile and:

- \* are seeking a fund that has low diversification
- \* are seeking to maximise returns
- \* can accept higher potential losses, especially in the short-term and
- \* are comfortable with the aforementioned specific risks associated with the Fund

**Suggested Length of Investment:** The Fund may be suitable for consumers who seek to invest their capital for a minimum timeframe of seven years.

**Access to Capital:** Withdrawal requests can be made daily, and must be received and accepted by the Fund's unit registry prior to 3pm (Sydney time) on a Business Day to be processed using that day's exit price. If received after 3pm, it will be processed using the next available price. Proceeds from your withdrawal will typically be available within 3-5 business days but can be up to 14 business days (i.e. during half-yearly distribution periods) from when we have accepted the request, given normal operating conditions. Please refer to the PDS for full details on the withdrawal conditions for the Fund and other factors that may delay or impact the payment of proceeds.

Capital Growth	The consumer seeks to invest in a product designed or expected to generate capital return over the investment timeframe. The consumer prefers exposure to growth assets (such as shares or property) or otherwise seeks an investment return above the current inflation rate.
Capital Preservation	The consumer seeks to invest in a product designed or expected to have low volatility and minimise capital loss. The consumer prefers exposure to defensive assets that are generally lower in risk and less volatile than growth investments (this may include cash or fixed income securities).
Income Distribution	The consumer seeks to invest in a product designed or expected to distribute regular and/or tax-effective income. The consumer prefers exposure to income-generating assets (this may include high dividend-yielding equities, fixed income securities and money market instruments).

<p>This TMD uses the Standard Risk Measure (SRM) to estimate the likely number of negative annual returns for this product over a 20 year period, using the guidance and methodology outlined in the Standard Risk Measure Guidance Paper For Trustees (note the bands in the SRM guidance differ from the bands used in this TMD). However, SRM is not a complete assessment of risk and potential loss. For example, it does not detail important issues such as the potential size of a negative return (including under conditions of market stress) or that a positive return could still be less than a consumer requires to meet their investment objectives/needs. The SRM methodology may be supplemented by other risk factors.
