**Important change to Perpetual's Select Superannuation Fund (the Fund)**

We're writing to inform you of an important upcoming change to your Fund, which includes:

- Perpetual Select Super Plan
- Perpetual Select Pension Plan.

**Proposed change of trustee**

The current trustee of your Fund, Perpetual Superannuation Limited (ABN 84 008 416 831 AFSL 225246 RSE L0003315) (PSL), has decided to retire as trustee of the Fund and enter into a Deed of Retirement and Appointment with Equity Trustees Superannuation Limited (ABN 50 055 641 757 AFSL 229757 RSE L0001458) (ETSL). Subject to the finalisation of all necessary legal agreements, ETSL will be appointed as the new trustee of the Fund with effect from 1 March 2025.

**Reason for the change**

The decision to retire as trustee and appoint ETSL as trustee follows a comprehensive review and has been made after considering the best financial interest of our members. The decision is aimed at leveraging the specialised expertise and extensive resources of ETSL, which is one of Australia's largest specialist trustee companies.

**Who is ETSL?**

ETSL was established as an independent trustee and executor company in 1888 and has become one of Australia's largest specialist trustee companies. ETSL operates as the trustee for a number of funds, bringing significant benefits such as economies of scale, strong governance, and access to a broad range of resources. ## What does this mean for you?

You don't need to take any action. Your account will continue to operate under the new trustee. Importantly, there are no changes to the features of the Fund, including the investment options and insurance offered, fees charged, pension payment arrangements, contact details, or the website as a result of the change of trustee.
